COMMERCIAL WARRANTY

EdgeWater Power Boats Commercial & Government Products warrants each new fiberglass boat manufactured (hull and deck) to be free from structural defects due to substandard material and workmanship under conditions of normal commercial use and service as follows:

1. Hull and Deck non pro-rated structural warranty, including fiberglass encased component parts, for repair or replacement for a period of 10 years from date of manufacture.
2. Component parts a 1 year period from date of manufacture
3. Accessories manufactured and installed by Edgewater Power Boats Commercial & Government Products for a period of 1 year from date of manufacture.

The Following Limitations Apply:

- A. Any Structural defects will be repaired free of charge at the Edgewater Power Boats facility or at an authorized repair location chosen by the manufacturer.
- B. Expenses for hauling out, transportation to and from the repair facility are the responsibility of the boat owner.
- C. Failures as a result of misuse, negligence, or accident damage caused by overpowering or repair from previous accidents.
- D. Windshield Breakage
- F. Engines, controls, batteries, gauges, propellers, trailers and other accessories or equipment manufactured and covered by other manufacturer's warranties.
- G. Installation of Engine/Engine parts or other accessories not installed by EdgeWater Power Boats Commercial & Government Products
- H. Normal wear and tear
- I. Gelcoat problems including, but not limited to; gelcoat crazing, radius fractures, discoloration, or blistering

Any claims for correction of defects will be made in writing to Edgewater Power Boats Commercial & Government Products. EdgeWater Power Boats Commercial & Government Products will at that time determine the appropriate and prudent action for correction. This will include authorization for repair, repair at the factory, or replacement at our discretion. It is understood the warranty is limited to correction of the defect and Edgewater Power Boats Commercial & Government Products assumes no liability for loss of use, consequential or incidental damages, or any implied warranty of merchantability or fitness for a particular use. No warranty regardless of form may be brought for breach of warranty more than one year after the cause of action accrues. EdgeWater Power Boats Commercial & Government Products reserves the right to revise this warranty as appropriate for the purposes of complying with specific bid requirements on an "as needed" basis.

To validate the warranty, the warranty registration information must be returned to Edgewater Power Boats Commercial & Government Products within 30 days by the original receiving agency.
